Dear Majority Leader McConnell,

Recent revelations showing Planned Parenthood officials discussing harvesting and selling baby body parts are yet another tragic and heart-breaking reminder that the nation's largest abortion provider has a legendary disregard for the sanctity of human life. It beggars the imagination that Planned Parenthood is willing to go to such grotesque lengths to profit from their abortion business.

We must not allow our consciences to become hardened to stories like the monster Kermit Gosnell snipping the spinal cord of born babies or Planned Parenthood harvesting the intact body parts of innocent human children as a matter of course.

Mr. Leader, if our government and the American people look the other way from this kind of insidious evil, we do so at our moral peril. Right now we have a feasible answer to end a large part of this barbarity. If the Pain Capable Unborn Child Protection Act, which protects unborn children beginning at the sixth month of gestation, had been in force, many of the older children with more mature organs would have been protected and their organs would not have been available to Planned Parenthood. We must send this bill to the President's desk.

The fact is, there is now incontrovertible scientific evidence that babies feel pain by at least at 20 weeks fetal age. When Dr. Deborah Nucatola, a top Planned Parenthood executive who performs abortions, described carefully crushing babies to preserve their organs, one shudders to think of the excruciating pain that the child feels.

A study by the Charlotte Lozier Institute found that the United States is one of just seven countries worldwide that permits elective abortion more than halfway through pregnancy (beyond 20 weeks).

It is an indescribable shame that America, the land of the free and the home of the brave, is leading the world in callous disregard for the most vulnerable among us. As you know, the House has already passed this critically important and timely legislation. It is time for the Senate to do the same.
